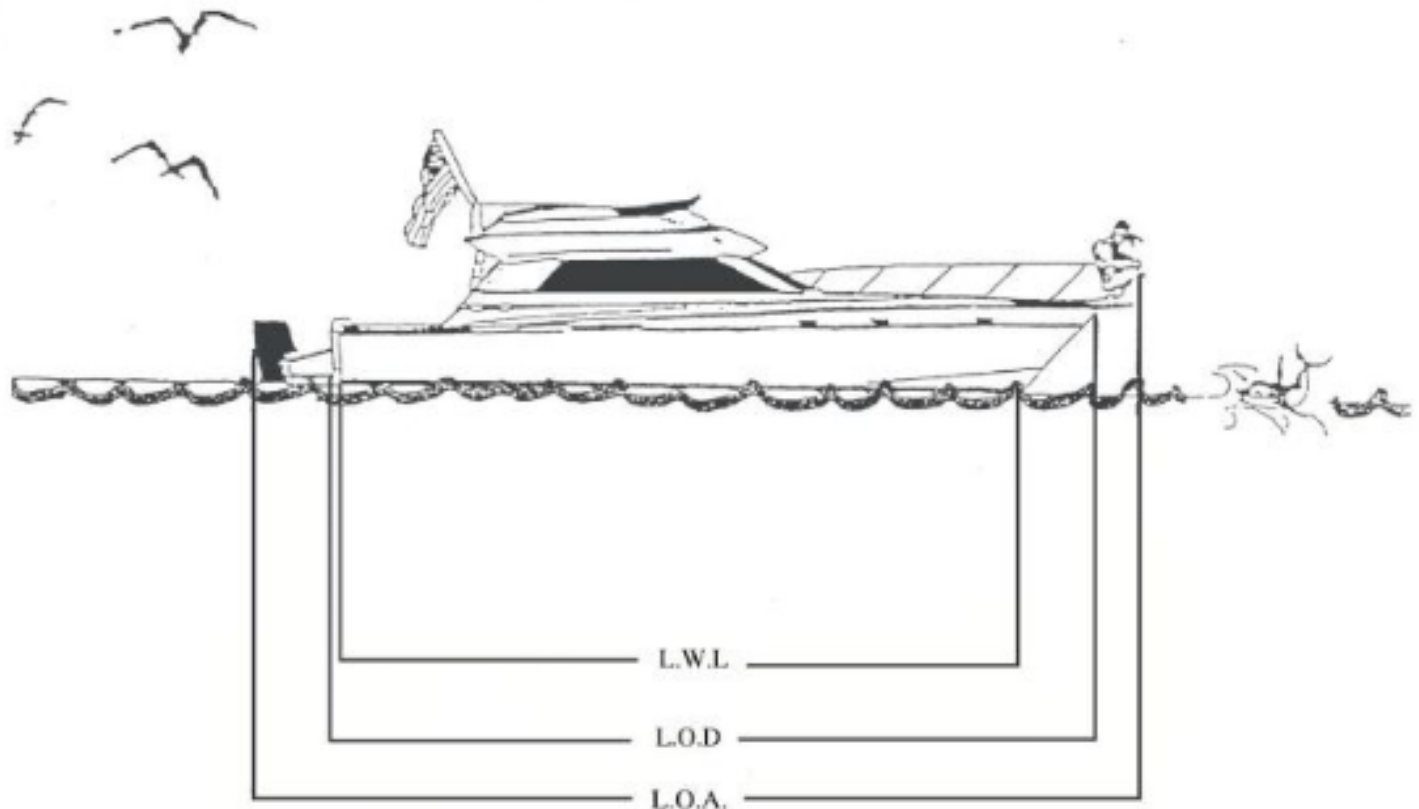
LENGTH DETERMINATION

Quoted yard rate per foot is applied to the length of the vessel as determined by its LOA to derive the rate per day

L.O.A. – Total linear measurement in feet and inches from the pointy end and rearward to the furthestmost protruding object, i.e. **LENGTH OVERALL**.

L.O.D. – Boat builders **LENGTH OF DECK**.

L.W.L. – Fish eye view, **WATERLINE LENGTH**



DIMENSIONAL CONSIDERATIONS:

Berthage is assigned by Marina Management with regard to a vessel's overall length, beam and operational characteristics. The overall length of a vessel shall be the measurement from the extreme point of the bow to the extreme point on the stern, including all gear and appurtenances. Management reserves the right to administer these policies on an individual basis to ensure fairness to all users.

a. Minimum Requirements

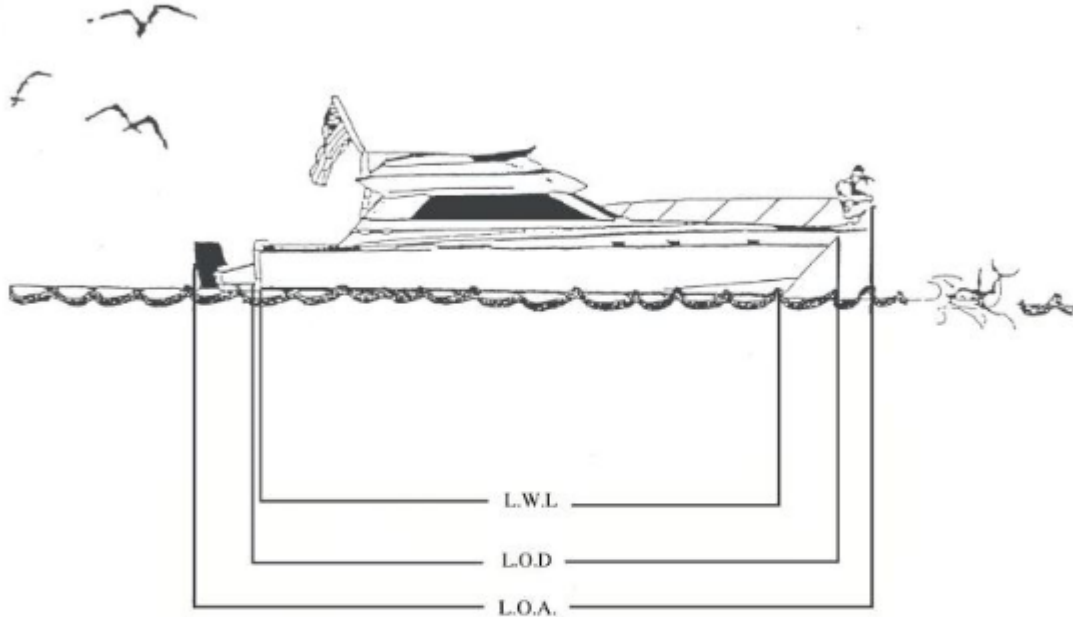
b. Maximum Requirements
